**HEALTH, SAFETY & WELFARE POLICY: STATEMENT OF INTENT 2020**

**Health and Safety Procedure Issue Date: 04 February 2021 - Re-assessed yearly.**

This Policy completely demonstrates that appropriate measures have been determined and applied.

The Direct Painting Group EST 1983 Ltd, recognises that all of their employees are the most valuable resource and that the health and safety of all employees is essential in achieving the Direct Painting Group's mission. The well being of all employees is of a primary concern thus, by investing in the health and welfare of employees the Direct Painting Group EST 1983 Ltd is investing in the efficiency and effectiveness of the organisation.

The Direct Painting Group is committed to creating a supportive working environment which is effective to the welfare of all of our employee. This policy is to provide and ensure high standards of health, safety, welfare and environment at work to prevent, so far as is reasonably practicable, accidental loss that may result in: Personal Injury, Ill Health, and Damage to plant and property.

Our objective is to achieve this, so far as is reasonably practicable, by providing an organisation structure which supports and implements appropriate risk assessment and risk control. Providing equipment and methods of work that are safe and without risk to health. Providing adequate welfare facilities that are maintained in an efficient manner. Ensuring that the arrangements for the use, storage, transport of articles and substances used at work are adequate. Setting up emergency procedures and providing information, instruction, training and supervision as necessary to assure health and safety at work. On all sites there is an appointed competent person to assist with the implementation of The Direct Painting Group EST 1983 Ltd Health & Safety arrangements. We also regularly review our health and safety performance, and set health and safety objectives aimed at improving the The Direct Painting Group EST 1983 Ltd safety performance.

**Roles of Responsibility**
